Additional appointments have been added to the Public Safety Headquarters screening dates on 10 and 11 February 2015. Other Police facilities for screening appointments include Area South on 17 February and Area North on 18 February 2015. Failure to complete your entire wellness program enrollment steps by the deadline dates, will incur a \$50 per non-participant increase in your monthly health care contributions.
